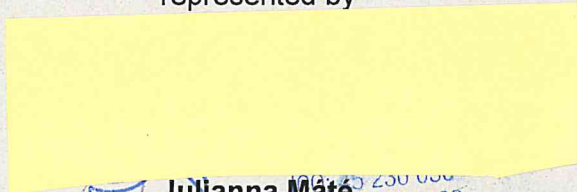
The modification of the Subsidy Contract doesn't affect the main purpose of the project approved by the Monitoring Committee.

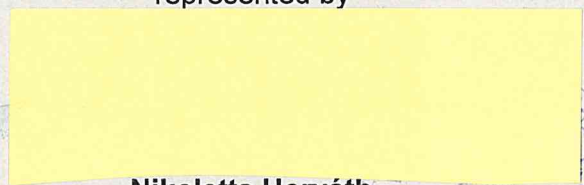
